## 1. OMFP Training

Oral and Maxillofacial Pathology (OMFP) in the UK is a dental specialty. Responsibility for the dental specialties lies with the General Dental Council (GDC). The curriculum for specialist training in OMFP is developed and published by the Oral and Maxillofacial Pathology Subcommittee of the Specialty Advisory Committee for the Additional Dental Specialties in conjunction with the British Society for Oral and Maxillofacial Pathology and is approved by the GDC. ## 2. What is the LEPT system?

The Learning Environment for Pathology Trainees (LEPT) system is an ePortfolio which is designed to capture trainees' progress during training. It records workplace-based assessments including multi-source feedback (MSF) and a functionality to support the Annual Review of Competence Progression (ARCP) process. The ePortfolio also provides the Educational Supervisor Structured Report (ESSR) which gives a snapshot of a year's training which is used to inform the ARCP.

## 3. Who is the LEPT system for?

The LEPT system is principally for registered medical trainees in the following CCT specialties:

- Chemical pathology
- Diagnostic neuropathology
- Forensic histopathology
- Histopathology
- Paediatric and perinatal pathology

From Autumn 2019, the LEPT system became available for use by CESR doctors in the above specialties wishing to make direct applications to the Specialist Register on the basis of training, qualifications and experience undertaken anywhere in the world. Prior to this, trainees on the International Trainee Support Scheme (ITSS) and the Medical Training Initiative (MTI) were also able to use the LEPT system.

The College received funding from Health Education England (HEE) to develop the LEPT system so as to include Oral and Maxillofacial Pathology (OMFP). This development work was completed to enable OMFP trainees to use the LEPT system from 1 September 2020.

A new LEPT system was launched in September 2021 in line with the newly GMC approved curricula for the above specialties. Its initial use was for new trainees who commenced pathology training from August 2021. After the ARPCs from spring 2022, all new trainees and those on the curricula prior to 2021 began using the new LEPT system.

## 4. Gaining access to the LEPT system

Please print and complete the application form which is at the end of this document and return it to the email address below. The information will be recorded on the College



database and trainees will receive an email notification requesting that a password be set. Email addresses and passwords are required to log into the College website in order to access the LEPT system.

## **5. Why do I need an Educational Supervisor?**

The support of an educational supervisor is important in assisting trainees in reviewing progress during the training. An educational supervisor (and a Training Programme Director) has to be selected in the LEPT system before the ePortfolio can be used. It is a mandatory requirement. It is the trainee's responsibility to ensure they have a designated educational supervisor and that the person have agreed to the role of reviewing the content of the trainee's ePortfolio via the LEPT system. The educational supervisor's consent must also be given on the application form.

## **6. How much does it cost to access the LEPT system?**

The fee for 2024/2025 is £65 for up to one years' LEPT access to run from 1 August to 31 July. This is despite the OMFP training year beginning in September.

## **7. How should the payment be made?**

Card payment must be made via the College website. Following the receipt of the application form, an email notification will be sent within three weeks to advise that the College website is open for the card payment to be made.

## **8. How will I know that I have been given LEPT access?**

LEPT access will begin from the receipt date of payment and an email notification will be sent to advise accordingly.

## **9. Can I re-apply to access the LEPT system for future years?**

Yes, you will be asked to pay the annual fee each year in July/August and as long as the fee is paid, your access to the LEPT system will continue. If you choose not to pay, your access will end.

After each ARCP panel meeting, please advise the College's LEPT contact (via email), your ARCP outcome number and year of training as appropriate. Your ePortfolio will be updated with this information.

## **10. I'm out of programme (OOP), do I need to pay for the use of the LEPT system?**

If you are OOP and require access to the ePortfolio, yes, the year's payment must be made.

If you are OOP and do not require the use of the ePortfolio, then no, payment is not required. However, please let the College know when you have returned to clinical training and wish to begin using the LEPT system.
